**RULES FOR THE CATERING CONTRACTOR AND CPRI
SUBSCRIBERS AS PER THE CONTRACT :**

1. House – Keeping Contract for the upkeep of rooms and cleanliness of campus has been given to M/S Archana Enterprises for the period of 11 months from 1st Nov. 2012.
2. Catering Contract for the restaurant & Bar (Deccan Hills) is being run by M/S Magarpatta Hospitality Services. The staff of the contractor including Cooks / Chefs and Manager shall be the well trained sufficiently experienced staff and the Cooks/ Chefs and Manager shall be well trained preferably from the reputed inside of Hotel Management, and the entire staff shall always be in proper attire.
3. The crockery, cutlery, utensils and other material and equipments which are reputed and branded, as used in Three Star restaurant/bar only shall be used while running the restaurant. Similarly the Entire Restaurant/Bar shall be run and managed at per with the Three Star standard.
4. **DISCOUNTS IN RESTAURANT AND BAR:** All Members of CPRI are requested to carry their CPRI Cards for availing discount . The dependents are also required to show the cards. CPRI Subscription to be paid at CPRI Office. Kindly note that discount will not be given unless CPRI Card is shown. The Restaurant/Bar/Banqueting shall be used for the benefit of the public and at concessional rate of 20% on food and 15% on liquor for the C.P.R.I. subscribers / non subscriber Police officers who would be staying at CPR & their family and one guest accompanying the Subscriber.
5. Police officers other than Subscribers and who are not staying at CPR will not be entitled for concessional rates.

However it is made clear that the Contractor shall be entitled to levy and recover taxes as applicable on the rates as mentioned above. (The term 'Family' as used in this Agreement shall mean and include spouse and unmarried children of the subscriber up to the age of 25 years, only.)CPR reserves the right to have Separate enclosure/reserved area for subscribers in the Restaurant/Bar.

6. The banquet hall, lawns are directly booked by C.P.R. and not any Contractor. The clients are free to engage a catering/ decorator of their choice and no contractor has its monopoly.
7. The booking charges for the upper and lower lawns shall be in the form of cheque / pay order or D. D. payable to the Secretary CPRI and the receipts will be passed from Receipt Book obtained from CPR.
8. For Upper and Lower lawns the venue charges would be as decided by Management from time to time for CPRI Subscribers and guests. The booking charges for the upper and lower lawns shall be in the form of cheque / pay order or D.D payable to the Secretary CPRI and the receipts will be passed by the Contractor as per the Receipt Book obtained from CPR.
9. Cleanliness of the Room and room service is the responsibility of the contractor. However, Booking & payment to be made to CPR Staff for rooms.
10. As per M.C. Meeting decision dtd.12.8.09, Police officers would be allowed to nominate/transfer their Subscriber ship of CPRI in civilian category to only one son/daughter on resigning from their CPRI Subscriber ship.
