
**RULES FOR THE CATERING CONTRACTOR AND CPRI
SUBSCRIBERS AS PER THE CONTRACT:**

- 1. House-keeping & Catering Contract for the restaurant, bar, banquet hall, lawns have been given to M/S Kezy Hospitalities Ltd.- Shri Arun Bidwai from 15.08.2009 for a period of 11 months initially.**
2. The Contractor shall have exclusive right of Catering and Mandap/decoration at Upper and Lower lawns of CPR situated at CPR, Pune Pashan Pune 411 008 during the contract period only. The booking charges for the upper and lower lawns shall be in the form of cheque / pay order or D.D. payable to the Secretary CPRI and the receipts will be passed by the Contractor as per the Receipt Book obtained from CPR. No outside catering / decoration other than Contractor is allowed during the Contract period.
3. The staff of the contractor including Cooks/Chefs and Manager shall be the well trained sufficiently experienced staff and the Cooks/Chefs and Manager shall be well trained preferably from the reputed institute of Hotel Management, and the entire staff shall always be in proper attire.

4. The crockery, cutlery, utensils and other material and equipments which are reputed and branded, as used in Three Star restaurant/bar only shall be used while running the restaurant. Similarly the Entire Restaurant/Bar shall be run and managed at par with the Three Star standard.

5. **DISCOUNTS IN RESTAURANT AND BAR:** All Members of CPRI are requested to carry their CPRI Cards for availing discount. The dependents are also required to show the cards. CPRI Subscription to be paid at CPRI Office. The Restaurant/Bar/ Banqueting shall be used for the benefit of the Public and at concessional rate of 20% on food and 15 % on liquor for the C.P.R.I. Subscribers / non Subscriber Police officers who would be staying at CPR & their family and one guest accompanying the Subscriber. Police Officers other than Subscribers and who are not staying at CPR will not be entitled for concessional rates. However it is made clear that the Contractor shall be entitled to levy and recover taxes as applicable on the rates as mentioned above. (The term 'Family' as used in this Agreement shall mean and include spouse and unmarried children of the subscriber upto the age of 25 years, only.) CPR reserves the right to have Separate enclosure/reserved area for subscribers in the Restaurant/Bar.

6. **For CPR POLICE WORKSHOPS** :-The Contractor shall provide Tea, Breakfast, Lunch, Hi-Tea, Dinner for the participants of various trainings/workshops organized by CPR with fixed menu including bed tea/Coffee, break fast, lunch, dinner (Veg/Non-veg), two teas/Coffee with biscuits during workshops. It is further agreed that there shall be a provision of meals on fixed Menu for the Police Officers coming on duty to Pune and staying at CPR @ the rate as may be decided by the management of CPR/CPRI in consultation with the Contractor.

7. For Upper and Lower lawns the venue charges would be as decided by the Management from time to time for CPRI Subscribers and guests. The booking charges for the upper and lower lawns shall be in the form of cheque / pay order or D.D. payable to the Secretary CPRI and the receipts will be passed by the Contractor as per the Receipt Book obtained from CPR.

8. Cleanliness of the Rooms and room service is the responsibility of the contractor. However, Bookings & payments to be made to CPR Staff for rooms.
